### **Previous damages / Repaintings**

The vehicle was found to have been properly and professionally repaired.

Essentially, the following vehicle parts were replaced or repaired:

- Fender le; ~ 210µm
- Door f.l.; ~ 300µm
- Door r.l.; ~ 180µm

A sample-like paint thickness measurement showed an increased paint thickness, which is almost certainly due to a repaired damage.


