The vehicle was found to have been properly and professionally repaired.

Essentially, the following vehicle parts were replaced or repaired:

- Door f.r.; ~ 250µm
- Door r.r.; ~ 230µm
- Side panel ri.; ~ 180µm

A sample-like paint thickness measurement showed an increased paint thickness, which is almost certainly due to a repaired damage.

## Test drive / Inspection

There was a short drive on the company site.

A test run of the engine was carried out.

An impairment of traffic safety was not detected.

The inspection included an external inspection of the vehicle without the dismantling of trim parts etc.

## Other information

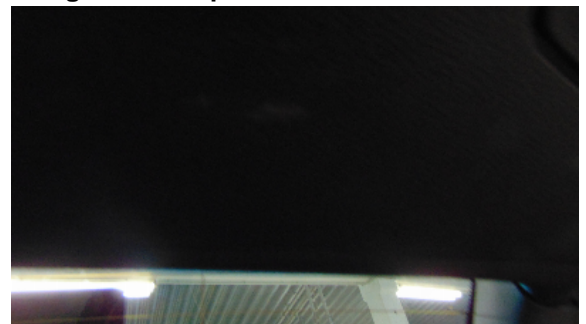

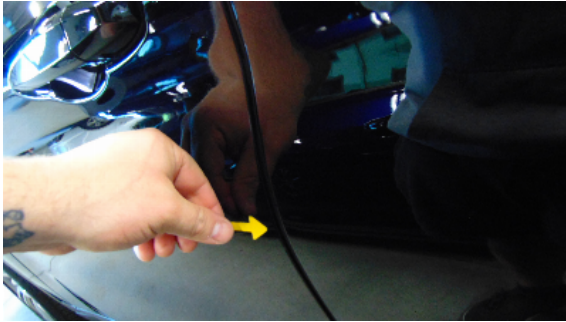
